





Potential risks

- the partnerships created ad-hoc only for participation in calls, without a real collaboration between participants (Romania-Norway-Iceland-Liechtenstein)
- excessive bureaucracy could take its toll on research activities
- funded research projects without a real projected impact in market
- lack of ambitions and plans for future cooperation and lack of funding opportunities suitable for continuation
